MIACCA Submits Public Comments on 2021 Part 5 Residential Code

MIACCA submitted the <u>following comments</u> on Friday, July 15, 2022. We will keep you posted on this matter as information is released. You can also check for updates on LARA's site <u>here</u>.

Construction Codes Commission Denies MIACCA's Request for Declaratory Ruling

MIACCA's Request for Declaratory Ruling for the Construction Code Commission (CCC) to prescribe all permit forms as required by mandatory provisions of <u>MCL 125.1510</u>; which states, in part: "The application shall be on a form prescribed by the commission and shall be accompanied by payment of the fee established by the enforcing agency."

Our request was on the July 20th CCC agenda and Executive Director M.J. D'Smith was in attendance at the meeting. The CCC went into closed session with their Attorney General representative. They returned and announced their denial by stating that this was already the law and that they have been approving permit forms that have been coming in. MIACCA is aware that this has not always been the CCC practice with past approvals. MIACCA has since put in a FOIA request for CCC approved forms in 2021 and 2022. We are also awaiting the written denial explanation that the CCC should be issuing.

MIACCA will keep you posted on our next steps to ensure that all permits our contractors are filling out, are indeed prescribed by the CCC, as the law requires. The next CCC meeting is October 12, 2022.




Gov. Whitmer Highlights Bipartisan Budget Investments to Grow Michigan's Economy & Workforce

Underground Mine Water for Heating and Cooling using Geothermal Heat Pump Systems

A partnership between the mining and geothermal industries could lead both toward a more lucrative and greener future.

Across the United States there are more than <u>3 million abandoned mining wells</u>. Each hole drilled into the ground offers more than just the ghost of minerals never found. There are layers of valuable data waiting for the right audience.

National Renewable Energy Laboratory (NREL) Senior Legal and Regulatory Analyst Aaron Levine said he hopes the mining industry becomes that audience.

In his new research, "Mining G.O.L.D. (Geothermal Opportunities Leveraged Through Data): Exploring Synergies Between the Geothermal and Mining Industries," Levine offers a two-pronged strategy of investigating mining data and taking advantage of hidden geothermal renewable energy resources.

"Our goal is really to target the mining industry for this opportunity and really make them understand the potential synergies between the two industries," Levine said.

Geothermal energy is a hidden asset, he said, often located one or two miles underground. It is challenging for the geothermal industry to spend millions in exploration and find nothing.

HVAC Prices Continue to Rise - Air Conditioning Manufacturers Announce Increases and 2020 v 2022 Comparison

Many HVAC manufacturers have already announced price increases going into 2022, making headlines as another round of price increases go into effect.

ACCA Fights Against Tax Increases for Small Businesses

The Air Conditioning Contractors of America (ACCA) joined 192 trade associations in opposing Congress's latest efforts to raise taxes on small, individually, and family-owned businesses as part of the effort to enact a reconciliation bill in 2022.

The letter, signed by ACCA and numerous other trade associations, urges Congress to reject two proposed tax increases that would fall entirely on small businesses, like many ACCA member companies.

The first increase would expand the 3.8% Net Investment Income Tax (NIIT) to individuals and families who actively participate in their business. The second would limit the ability of small businesses to deduct their losses during an economic downturn by expanding and extending the "excess business loss limitation" for "noncorporate taxpayers."

"These increases will do nothing but harm ACCA members that are small, individually, and family-owned businesses, as well as many others in the HVACR industry," said Barton James, ACCA president and CEO. "ACCA will do everything we can to prevent these unfair tax increases and protect these essential businesses that are responsible for keeping our economy moving."
