State of Michigan LARA Update



Bureau of Construction Codes December 20, 2017 Public Meeting Update

MCL 125.1504 allows for Michigan to "skip" a code cycle and adopt a new International Residential Code version every 6 years. The purpose of the meeting was to allow persons an opportunity to present data and comments on the general need to update the current 2015 Michigan Residential Code (MRC) with the 2018 edition of the International Residential Code (IRC).

Our Executive Director was in attendance and on behalf of MIACCA submitted testimony supporting adopting the 2018 IRC with Michigan amendments. The reasoning behind this positions was that after reviewing the 2018 IRC there is not too much difference from the 2015 MRC to the 2018 IRC and given the uncertainty of what might be coming in the 2021 IRC, MIACCA thinks having the 2018 IRC for 6 years is the better option for Michigan at this time.

The other general consensus of public comments were supportive of the 2018 IRC, but many had concerns over adopting the Michigan amendments due to concerns of lack of review, amendments have

errors, lack of DOA compliance and Res Check is not supported.

The Bureau will reviewing these comments and will make their final decision within thirty days. The results will be posted on their website and MIACCA will send the decision to members.
