The Governor likely looked at this issue strictly from the standpoint of streamlining and speeding up the code promulgation process and never considered (or was never told) the ramifications of this change, but that does not mean that the struggle ends. Next year, we will have new administration to whom we can present this bill.

This gives a new chance to make our case for returning to the old but better code promulgation process.

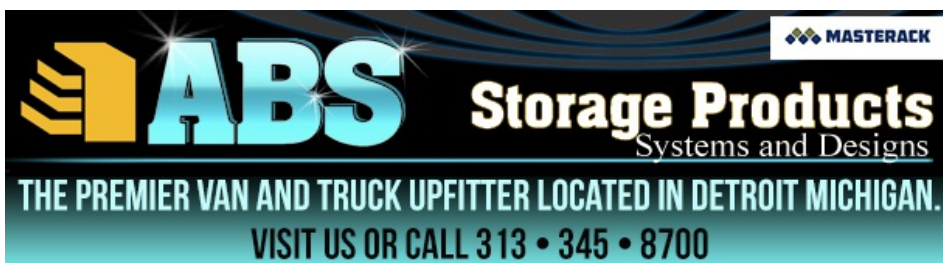
