## Michigan Legislative Update

**MECHANICAL LICENSE HOLDERS BEWARE now that the Forbes Mechanical Contractors Act has been replaced with the Skilled Trades Regulation Act.**

As many of you know, the former Forbes Mechanical Contractors Act was not enforced that often. However the new Skilled Trades Regulation Act (STRA) makes it much easier to go after unlicensed activities. [Article 6](#) of the STRA states in Sec. 601 that “a person shall not engage in or attempt to engage in the practice of an occupation regulated under this act or use a title designated in this act unless the person possesses a license issued by the department for the occupation”. Which not only means a person with no mechanical license cannot engage in mechanical work as identified in [Article 8](#) of the STRA, but also means that a person without the proper mechanical license classifications cannot do other mechanical work that requires a different mechanical license classification. Such as a person with an HVAC Equipment mechanical license classification, who is licensed to install HVAC equipment and systems, may not do limited heating service work for which a “limited heating service” license classification is required.

Sec. 603 of the STRA, states that “if a person violates this act or a rule or order promulgated or issued under this act, the department shall assess penalties”; which could include “if the person is licensed under this act and except as otherwise provided in this act, an administrative fine to be paid to the department of not more than \$10,000.00”. Basically this provision is indicating that if you are already licensed under the STRA that you should know better and that because you are licensed under the STRA you are subject to an additional fine of up to \$10,000. So those with mechanical licenses may want to think twice about doing mechanical work for which they do not have the proper mechanical license classification.

This potential fine is in addition to the other provisions of Sec. 607 of the STRA; which identifies the following as violations of the STRA: practices fraud, deceit, or dishonest in practicing an occupation; demonstrates a lack of good moral character; commits an act of gross negligence in practicing of an occupation; practices false advertising; commits an act that demonstrates incompetence; and aids or abets another person in the unlicensed practice of an occupation.

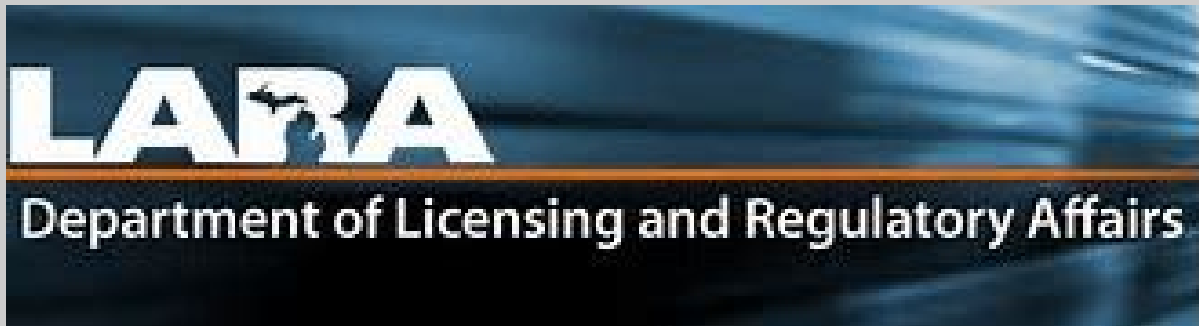

## **HB 5376 Update– Required Code Advisory Committees**

On Wednesday, January 10, 2018, [HB 5376](#) was introduced by Reps. Iden, Bellino, Kesto, Crawford, Griffin, Webber, Brann and McCready and referred to the Committee on Regulatory Reform.

The introduced bill would amend the [Stille-DeRossett-Hale Single State Construction Code Act, PA 230 of 1972](#) to require the Director, before adopting new editions of Michigan construction codes, to appoint specific advisory committees to review the proposed codes in public meetings and make recommendations to the Director. HB 5376 calls out for industry experts and other appropriate representation to be on the different advisory committees.

MIACCA is in support of the initial concept behind the bill and will be working to bring more mechanical expertise and transparency to Michigan mechanical codes and regulations. We will continue to keep you posted of any updates we receive.



## **Michigan Regulatory Update**

### **2015 Michigan Residential Code to remain In effect for 3 more years**

The Bureau of Construction Codes has just [announced](#) that the Michigan will not be updating to the 2018 International Resident Code. Which means the 2015 Michigan Residential Code will remain in effect until Michigan adopts the 2021 International Residential Code with Michigan amendments.

### **Gov. Rick Snyder Reorganizes Agency for Energy**

LANSING, Mich. – Gov. Rick Snyder today announced a restructuring of the Michigan Agency for Energy (MAE) and the Michigan Public Service Commission (MPSC) with Executive Order 2018-1. However this order keeps the Energy Ombudsman for monitoring the Code of Conduct, on-bill utility financing, and serving as a liaison for business and individuals. As well as a change in the chair of the Pipeline Safety Advisory Board in response to MAE Executive Director Valerie Brader's resignation from the administration.
